AN ORDINANCE AMENDING THE SALARY SCHEDULE OF ORDINANCE NO. 12187 (THE SALARY ORDINANCE) TO: ADD THE PERMANENT PART TIME (PPT) AND PART TIME (PT) EQUIVALENT CLASSIFICATIONS OF: REAL ESTATE AGENT, PT; RECEPTIONIST TO THE CITY AUDITOR, PT; REAL ESTATE AGENT, PPT RECEPTIONIST TO THE CITY AUDITOR, PPT; CONTRACT COMPLIANCE OFFICER, PPT; AND POLICE RECORDS SPECIALIST, PPT


