INTRODUCED BY COUNCILMEMBER NOEL GALLO

RESOLUTION AUTHORIZING COUNCILMEMBER NOEL GALLO TO REPRESENT THE CITY OF OAKLAND AS THE VOTING DELEGATE AT THE NATIONAL LEAGUE OF CITIES 2022 CITY SUMMIT CONFERENCE NOVEMBER 17, 2022, THROUGH NOVEMBER 20, 2022, IN KANSAS CITY, MISSOURI AND AUTHORIZING REIMBURSEMENT FOR NECESSARY EXPENSES FOR ATTENDANCE AT THE CONFERENCE IN THE AMOUNT OF \$3,695.00 FOR REGISTRATION FEES, HOTEL, AIR FARE AND PER DIEM FROM THE COUNCIL CONTINGENCY PROJECT FUND

WHEREAS, Councilmember Noel Gallo, is the City of Oakland's Voting Delegate to the National League of Cities, and the League's 2022 City Summit Conference is being held in Kansas City, Missouri, from November 17- 19, 2022, and;

WHEREAS, City Council Resolution No. 82800 C.M.S, approved by the City Council on June 1, 2010, establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves transportation and lodging and shall provide an estimate of the cost of transportation, lodging, per diem and conference fees when City funds are used as well as the source of City funding that will be used to cover said travel expenses; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated costs are \$3695, including Councilmember Gallo's conference registration fees (\$880), airfare (\$765), lodging (\$1,800) and per diem (\$250), all costs within the City of Oakland's approved travel policies and procedures, and;

WHEREAS, the City Council Contingency Project fund is the source of City funding that will be used to cover these travel costs; and

WHEREAS, Councilmember Noel Gallo seeks City Council approval for the aforementioned estimated costs to travel to and attend the National League of Cities 2022 City Summit Conference; now, therefore, be it

RESOLVED: That Councilmember Noel Gallo is hereby authorized to represent the City of Oakland as the Voting Delegate at the National League of Cities 2022 City Summit Conference; and be it

FURTHER RESOLVED: That all expenses incurred for said travel are hereby authorized.


