**RESOLUTION AUTHORIZING COUNCILMEMBER ABEL GUILLÉN TO TRAVEL TO WASHINGTON, DC TO ATTEND THE 33<sup>RD</sup> ANNUAL NATIONAL ASSOCIATION LATINO ELECTED OFFICIALS (NALEO) 2016 CONFERENCE FROM JUNE 22-25, 2016**

**WHEREAS**, Councilmember Abel Guillén, wishes to attend the 33<sup>rd</sup> Annual NALEO 2016 Conference in Washington, DC from June 22-25, 2016; and

**WHEREAS**, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City and/or Redevelopment Agency funding that will be used to cover the travel costs; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation (including airfare and taxis) is \$783.00, of lodging is \$645.00 for three nights, of per diem is \$241.50 for three days, and of conference registration fees is \$600.00, approximately \$2,300.00; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from Councilmember Guillén's District 2 existing budget; and

**WHEREAS**, Councilmember Abel Guillén seeks Council approval of the forementioned estimated costs to travel to Washington, DC to attend the 33<sup>rd</sup> Annual NALEO 2016 Conference from June 22-25, 2016; now, therefore, be it

**RESOLVED:** That all expenses incurred for said travel are hereby authorized.
