#### **SUMMARY**

This report is written in response to Council's request regarding the City of Oakland's 2010-2012 Cal-GRIP application.

#### FISCAL IMPACT

There is no fiscal impact information contained in this report.

### **BACKGROUND**

The City of Oakland's High School Career Pathway and Community Collaborative represents the formation of a broad-based partnership applying innovative practices to reduce violence, create career pathways, improve school environments; provide services to surrounding neighborhood residents on the school campuses; and provide an initial college experience to high school students using a relatively small amount of funding. Taken together, the partnership approach can increase public safety for young people and residents of their neighborhood. The project is grounded in discussions by the original Fremont High-School Collaborative which concluded that reducing gang involvement would require providing for young people the things that gangs are often seen to provide – a sense of belonging, protection, and economic resources.

The California Emergency Management Agency (Cal-EMA) awarded a grant of \$382,639 in April 2010. "Paul Seave, director of the Governor's Gang and Youth Violence Policy, said about the grant, "This project has the refreshingly high but reasonable expectation that gang-involved youth have what it takes to complete high school and college and embark on a teaching or social service career, if there is effective support."

#### **KEY STRATEGIES:**

• Fuse curriculum and training into a seamless career pathway for Oakland youngsters to enter careers in education and community service

- Reduce gang involvement through the hiring of two Youth Engagement Coordinators with particular skills at helping young people to resist gangs and create a sense of belonging and community at the two high school campuses.
- Provide part-time employment in after-school programs or community-based organizations to 70 students at Fremont and Castlemont, schools which have been disproportionately impacted by violence.
- Leverage community-wide supportive services to ensure success of participants and neighborhood families.
- Establish physical homes for the Fremont and Castlemont Community Collaborative at Fremont and Castlemont High Schools that will serve as youth and community resource centers.
- Provide an assessment of the extent of gang-violence at the two campuses.
