

RESOLUTION CONFIRMING THE MAYOR'S REAPPOINTMENT OF JULIE JONES AND PATRICK FORTE AS MEMBERS OF THE COMMISSION ON AGING

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No 9921 C.M.S. adopted May 13, 1980 and amended in 1985, 1989 and 1995 establishes the Commission on Aging to advocate for the elderly and to serve as an Advisory Board to the Department on Aging; and

WHEREAS, the Commission on Aging consists of eleven (11) members serving not more than two consecutive three-year terms; and

WHEREAS, Julie Jones was appointed and confirmed for the first time as a member of the Commission on Aging by Resolution No. 83144 C.M.S. on or about January 18, 2011 to a three-year term beginning September 2, 2010 and ending September 1, 2013; and

WHEREAS, Patrick J. Forte was appointed and confirmed for the first time as a member of the Commission on Aging by Resolution No. 84173 C.M.S. on or about January 22, 2013 to a three-year term beginning September 4, 2010 and ending September 3, 2013; and

WHEREAS, the Honorable Mayor Jean Quan has reappointed Julie Jones and Patrick Forte to serve another three-year term each, subject to confirmation by the City Council; now therefore be it

RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of:

Julie Jones to the Commission on Aging for a three-year term beginning September 2, 2013 and ending August 31, 2016, filling the seat previously held by herself.

Patrick Forte to the Commission on Aging for a three-year term beginning September 4, 2013 and ending August 31, 2016, filling the seat previously held by himself.
