ORDINANCE AUTHORIZING A FISCAL YEAR
2015-16 INCREASE TO A SPECIAL TAX IMPOSED
FOR EMERGENCY MEDICAL SERVICES, IN AC-
CORDANCE WITH THE CONSUMER PRICE IN-
DEX, AND PURSUANT TO THE EMERGENCY
MEDICAL SERVICES RETENTION ACT OF 1997
(MEASURE M)**

This Ordinance would authorize an increase of the special tax imposed for emergency medical services pursuant to Measure M for Fiscal Year 2015-2016 in the amount 2.8%, which represents the cost-of-living increase based on the San Francisco Bay Area Consumer Price Index from calendar year 2013 to calendar year 2014.
