**AN ORDINANCE AMENDING THE MASTER FEE SCHEDULE TO ADD
A \$400.00 APPLICATION FEE RELATED TO CHAPTER 5.80 OF THE
OAKLAND MUNICIPAL CODE ENTITLED MEDICAL CANNABIS
DISPENSARY PERMITS**

WHEREAS, the City Council established a Medical Cannabis Dispensary business permit pursuant to Chapter 5.80 of the Oakland Municipal Code; and

WHEREAS, the City Council has determined that a \$400.00 application fee shall be required of all applicants wishing to obtain a Medical Cannabis Dispensary business permit to cover the cost of processing and noticing; now therefore be it

RESOLVED THAT THE CITY COUNCIL HEREBY ORDAINS THAT THE MASTER FEE SCHEDULE SHALL BE AMENDED AS FOLLOWS:

Section 1. The City Manager Special Permit Activity Section of the Master Fee Schedule is hereby amended to read:

25. Medical Cannabis Application Fee \$400.00

Section 2. The City Council finds and determines that the foregoing recitals are true and correct, are an integral part of this ordinance, and provide findings to support the Ordinance.

Section 3. The Ordinance shall be effective upon final passage if it receives six or more affirmative votes and shall be effective seven days after final passage if it receives five affirmative votes.
