**RESOLUTION INITIATING THE FISCAL YEAR (FY) 2022-23
ASSESSMENT PROCESS FOR THE CITY OF OAKLAND
LANDSCAPING AND LIGHTING ASSESSMENT DISTRICT (LLAD) AND
AUTHORIZING THE CITY ADMINISTRATOR TO ORDER A
PRELIMINARY ENGINEER'S REPORT**

WHEREAS, pursuant to the California Streets and Highways Code, Sections 22500, et seq., known as the Landscaping and Lighting Act of 1972, the City established the Landscaping and Lighting Assessment District ("LLAD" or the "District") on June 23, 1989; and

WHEREAS, pursuant to California Streets and Highway Code sections 22500 et seq., the City has renewed the District each subsequent year; and

WHEREAS, California Streets and Highways Code Section 22622 requires that the City Council adopt a resolution describing any proposed new improvements, or any substantial changes in existing improvements, and ordering the District engineer to prepare and file a report with the City Clerk for further submission to the City Council; and

WHEREAS, City is not proposing any new improvements or any substantial changes in existing improvements; and

WHEREAS, the City desires to initiate the FY 2022-23 LLAD assessment for properties within the district boundaries for the purpose of raising tax revenue that will be used to support the regular capital improvement of existing facilities and amenities within the LLAD in addition to the installation, maintenance, and servicing of public landscaping and lighting; now, therefore, be it

RESOLVED: That the City Council hereby initiates the annual assessment process for the City of Oakland LLAD for FY 2022-23; and be it

FURTHER RESOLVED That on the basis of the City Administrator's report accompanying this resolution, the City Council finds that there are no new improvements or any substantial changes in existing improvements of the LLAD and the boundaries and improvements remain the same as those described in the FY 2021-22 Engineer's Report approved by the City Council, pursuant to Resolution No. 88650 C.M.S., on May 18, 2021; and be it

FURTHER RESOLVED: That the City Council authorizes the City Administrator to order a preliminary engineer's report for FY 2022-23 for the City of Oakland Landscaping and Lighting Assessment District; and be it

FURTHER RESOLVED: That, upon completion, the preliminary engineer's report shall be filed with the City Clerk for submission to the City Council for further action.


