

INTRODUCED BY COUNCILMEMBER SCHAAF

A RESOLUTION COMMENDING SHIRLEY BURNELL AND SHARON CORNU AS THE FIRST RECIPIENTS OF THE COMMUNITY LEADER AND LABOR LEADER AWARDS BY THE EAST BAY ALLIANCE FOR A SUSTAINABLE ECONOMY

WHEREAS, The East Bay Alliance for a Sustainable Economy (EBASE) is celebrating twelve years of building a vibrant Oakland and East Bay, where workers have a voice on the job, neighbors engage in community decisions, and kids grow up to fulfill their dreams; and

WHEREAS, in its 12-year history, EBASE has impacted the lives of 20,000 workers and community members in Oakland and the East Bay by raising workplace standards, increasing job access, and boosting income; and

WHEREAS, at its 12th anniversary celebration on October 5th, EBASE presented its first-ever Community Leader and Labor Leader Awards; and

WHEREAS, Shirley Burnell is the first recipient of the Community Leader of the Year award; and

WHEREAS, Ms. Bumell is a dedicated leader in West Oakland with Alliance of Califomians for Community Empowerment (ACCE) and a leader in EBASE's coalitions inspiring our community to build a better Oakland for our grand children and future generations with good jobs, safe streets, high quality schools and affordable housing; and

WHEREAS, Sharon Comu is the first recipient of the Labor Leader of the Year award; and

WHEREAS, As the Executive Secretary-Treasurer of the Alameda Labor Council, AFL-CIO for nearly eight years, Ms. Comu led the East Bay's fight to rebuild an American middle class, and as a member of the EBASE Board of Directors, she was instrumental in building the organization into a strong labor-community-faith alliance; now therefore be it
