## **SUMMARY**

The Port of Oakland has offered the Police Department \$19,271.94 to purchase emergency preparedness audio/visual communications equipment, hardware, and related computer support. The equipment will provide the Department communications interoperability with the Port of Oakland in the event of a disaster – either man-made or natural..

### FISCAL IMPACT

The Port of Oakland has awarded the Police Department \$19,271.94 for the purchase of Emergency Audio/Visual Communications Equipment. The monies will be appropriated to the General Fund: 1010, in Org. No.: 104641; Special Operations.

#### BACKGROUND

In July 2003, the Port of Oakland was awarded a grant in the amount of \$150,000 from the Maritime Administration and Transportation Security Administration. The grant monies were to be allocated for the installation of an Emergency Communication System for its terminal operations. Port security officials have offered OPD \$19,271.94 to purchase tactical, interoperable communications equipment as part of the City's mutual cooperation Memorandum of Understanding.

### KEY ISSUES AND IMPACTS

The money will be used to purchase wireless audio/visual communications hardware, software, and related computer support. The equipment will work in concert with the ACU-1000 device, which provides direct audio or voice-band connectivity between disparate radio systems, during operations and critical incidents. The audio equipment will provide interconnectivity between OPD and the California Highway Patrol, the Alameda County Sheriff's Office, the U.S. Coast Guard, Port terminal operators, and Port security. The wireless video equipment will provide real-time visual information to OPD from an incident scene.

## SUSTAINABLE OPPORTUNITIES

**Economic** – Maintaining the safety and security of the Port is vital to the region's economy.
