WHEREAS, AXIS Dance Company, based at the Malonga Casquelourd Center in Oakland, celebrates 30 years of changing the face of dance and disability through Artistry, Engagement and Advocacy; and

WHEREAS, AXIS Dance Company was one of the first contemporary dance companies in the world to create a company based on the integration of dancers with and without physical disabilities as equals; and

They empower youth and adults by providing inspiring role models who do what they love – no matter what; and

WHEREAS, AXIS Dance Company represented the vibrancy and diversity of the City of Oakland's creative community through their two appearances on the nationally televised FOX reality show So You Think You Can Dance; and

WHEREAS, AXIS Dance Company is the nation's leading physically integrated dance company and has made Oakland an internationally-recognized center and a destination for professional training in physically integrated dance; and

WHEREAS, AXIS Dance Company is the acknowledged leader in advancing equity for people with disabilities in dance as illustrated by their hosting of the first-ever National and Regional convening on the Future of Physically Integrated Dance in the USA and their role in creating the first Dance and Disability Affinity Group in partnership with Dance/USA; and

WHEREAS, AXIS Dance Company has broken new ground in and contributed greatly to the cannon of contemporary dance and disability culture and is a jewel of both. AXIS has made an indelible impact on dance, disability and the City of Oakland; now, therefore, be it


