INTRODUCED BY COUNCILMEMBER NOEL GALLO

ADOPT A RESOLUTION AUTHORIZING REIMBURSEMENT FOR COUNCILMEMBER NOEL GALLO'S COSTS OF APPROXIMATELY \$2,887 FROM THE COUNCILCONTINGENCY FUND FOR TRAVEL TO WASHINGTON, DC FOR ATTENDANCE AT THE NATIONAL LEAGUE OF CITIES' CONGRESSIONAL CITY CONFERENCE FROM MARCH 7 - 11, 2020

WHEREAS, Councilmember Noel Gallo, is City of Oakland's Alternate Voting Delegate to the League of California Cities, is requesting authorization reimbursement to travel to Washington, DC to attend the National League of Cities' Congressional City Conference from March 7 - 11, 2020; and

WHEREAS, City Council Resolution No. 82800 C.M.S approved by the City Council on June 1, 2010 requires that, when Councilmembers seek Council approval for using City funds for travel, their agenda materials shall indicate whether travel involves airline transportation and lodging and shall provide an estimate of the cost of airline, lodging, per diem and conference fees and the source of City funding that will be used to cover the travel cost; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost for Councilmember Gallo's Washington, DC trip is \$740.00 registration fee, \$285 for the NLC University Policy Priorities to Practice Class, up to \$1,482.69 for four nights of lodging, up to \$198.00 per diem, and up to \$379.96 for air fare; and

WHEREAS, Councilmember Noel Gallo seeks City Council approval for the aforementioned cost to travel to Washington, DC to attend the National League of Cities' Congressional City Conference; now, therefore, be it

RESOLVED: That all expenses incurred for said travel are hereby authorized.
