RESOLUTION COMMENDING THE DEDICATED SERVICE, ACCOMPLISHMENTS AND LEADERSHIP OF RONALD L. DAVIS TO THE CITY OF OAKLAND

WHEREAS, Ronald L. Davis was promoted to Sergeant of Police on September 11, 1992, serving stints in the Jail Division, Patrol Division, Ranger Unit, and the Vice Section of the Criminal Investigation Division (CID), receiving the Medal of Merit for his role as supervisor of Special Duty II in the planning and implementation of Operation Reverse Play, a narcotics enforcement strategy, in October 1997; and

WHEREAS, Ronald L. Davis was promoted to Lieutenant of Police in May 1997, where he served in the Special Operations Division, the Patrol Division, and in March 1998 was named commander of the Training Section; and

WHEREAS, Ronald L. Davis was promoted to Captain of Police on January 9, 1999, where he served as commander of the Criminal Investigation Division (CID), Patrol Division Area III, Training and Personnel Division, and the Youth and Community Services Division; and

WHEREAS, Ronald L. Davis' well deserved national reputation as a police reform expert and expert in bias-based policing and the strategies law enforcement agencies need to develop to eliminate such practices has resulted in his participation on several Department of Justice affiliated monitoring teams and his recognition by the National Organization of Black Law Enforcement (NOBLE) executives in 2001when he was selected to receive the NOBLE / Lexis Nexis Civil Rights Impact Award; and

WHEREAS, Ronald L. Davis in his role as the Department's Inspector General, since September 2003, has brought particular distinction to himself and the Police Department for his tireless efforts to bring the Department into compliance in all areas of the Negotiated Settlement Agreement, for which he received the Chief's Leadership Award in May 2005; now, therefore be it
