RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, ON BEHALF OF THE CITY OF OAKLAND, TO ACCEPT AND APPROPRIATE GRANT FUNDS IN AN AMOUNT NOT TO EXCEED TWENTY-ONE THOUSAND FIVE HUNDRED DOLLARS (\$21,500) FROM THE STATE OF CALIFORNIA, GOVERNOR'S OFFICE OF EMERGENCY SERVICES, FISCAL SERVING AS THE AGENT FOR PROJECT SAFE NEIGHBORHOODS, AS ADMINISTERED THROUGH THE OFFICE OF THE U.S. ATTORNEY FOR THE NORTHERN DISTRICT OF CALIFORNIA IN SUPPORT OF THE OAKLAND HOMICIDE TASK FORCE PROGRAM IN THE POLICE DEPARTMENT

WHEREAS, it is anticipated that grant funds in an amount not to exceed \$21,500 will be received from the State of California, Governor's Office of Emergency Services, in support of the Oakland Homicide Task Force Program in the Police Department; and

WHEREAS, these grant funds are to be used to expand law enforcement efforts to address gun violence and narcotics trafficking problems through comprehensive programs in the City of Oakland; and

WHEREAS, the City Council previously authorized acceptance of similar grant funds by Resolution No. 78555 C.M.S., dated May 18, 2004; now, therefore, be it

**RESOLVED:** That the City Council hereby authorizes the City Administrator or her designee to accept and appropriate grant funds in an amount not to exceed \$21,500 from the State of California, Governor's Office of Emergency Services to the Police Department; and be it

**FURTHER RESOLVED:** That the funds for the Oakland Homicide Task Force Program shall be maintained in the State of California Grant Fund: 2152, Homicide Division Org.: 102320, Homicide Division Program: PS03, in a Project Account to be determined; and be it

FURTHER RESOLVED: That the City Administrator or her designee is authorized to complete all required negotiations, certifications, assurances, and documentation required to accept, modify, extend and/or amend the grant award; and be it

**FURTHER RESOLVED:** That the City Council hereby authorizes the City Administrator, as agent of the City, to conduct all negotiations and related actions and to sign all applications and agreements that may be necessary for the completion of the aforementioned grant.
