

**A RESOLUTION AUTHORIZING A \$2,211,000 AFFORDABLE HOUSING DEVELOPMENT LOAN TO EAST BAY ASIAN LOCAL DEVELOPMENT CORPORATION AND NATIVE AMERICAN HEALTH CENTER FOR THE NATIVE AMERICAN HEALTH CENTER PROJECT LOCATED AT 2946 INTERNATIONAL BOULEVARD, AND CONSOLIDATING AN EXISTING \$1,078,000 SITE ACQUISITION LOAN WITH THE DEVELOPMENT LOAN, FOR A NEW TOTAL DEVELOPMENT LOAN IN AN AMOUNT NOT TO EXCEED \$3,289,000**

**WHEREAS**, the Redevelopment Agency has previously provided a \$1,078,000 loan (the "Site Acquisition Loan") to East Bay Asian Local Development Corporation and Native American Health Center (together, the "Developers") through the Agency's Affordable Housing Site Acquisition Loan Program as authorized by Redevelopment Agency Resolution No. 00-55 C.M.S., dated July 25, 2000, to be used to acquire a site at 2946 International Boulevard; and

**WHEREAS**, the Site Acquisition Loan was for a term of 3 years, with a simple interest rate of 5.01 percent per year; and

**WHEREAS**, on September 10, 2002, the Redevelopment Agency and the City of Oakland jointly issued a Notice of Funding Availability ("NOFA") soliciting applications for funding for affordable housing developments; and

**WHEREAS**, Developers submitted a proposal in response to the NOFA to develop a 38 unit housing project known as Native American Health Center on the site acquired with the Site Acquisition Loan (the "Project"); and

**WHEREAS**, 37 Project units will be rented at prices affordable to households earning no more than 80% of area median income; and

**WHEREAS**, the City of Oakland's Consolidated Plan for Housing and Community Development indicates that there is a need for affordable rental housing, and has identified this activity as a priority; and

**WHEREAS**, the Project is consistent with the Agency's Project Development Guidelines, and Developers meet the Agency's Threshold Developer Criteria; and

**WHEREAS**, the Project will increase and improve the supply of low and moderate income housing available in the City of Oakland, is an eligible use of the Agency's Low and Moderate Income Housing Fund under California Health and Safety Code Sections 33334.2 and 33334.3, and will benefit the redevelopment project areas in the City of Oakland by providing affordable housing opportunities within the community that will enhance the economic viability and redevelopment potential of the project areas; and

**WHEREAS**, no other reasonable means of private or commercial financing of the Project at the same level of affordability and quantity are reasonably available to Developers other than the Low and Moderate Income Housing Fund; and

**WHEREAS**, the Agency by agreement with the City is the Lead Agency for this Project for purposes of environmental review under the California Environmental Quality Act of 1970 ("CEQA"); and

**WHEREAS**, the requirements of CEQA, the CEQA Guidelines as prescribed by the Secretary for Resources, and the provisions of the Environmental Review Regulations of the City of Oakland have been satisfied; and

**WHEREAS**, funds are available from the Agency's Low and Moderate Income Housing Fund and Affordable Housing Bond Fund to assist the Project; now, therefore, be it

**RESOLVED:** That the Redevelopment Agency hereby authorizes the Agency Administrator or his designee to provide an additional loan in an amount not to exceed \$2,211,000 to East Bay Asian Local Development Corporation and Native American Health Center, or to an affiliated entity approved by the Agency Administrator or his or her designee, to be used for development of the Project; and be it further

**RESOLVED:** That loan funds shall come from the Agency's Low and Moderate Income Housing Fund and Affordable Housing Bond Fund; and be it further

**RESOLVED:** That the loan is contingent on the availability of sufficient funds in the Low and Moderate Income Housing Fund and Affordable Housing Bond Fund to cover the loan; and be it further

**RESOLVED:** That the Agency hereby authorizes the Agency Administrator or his designee to convert the Site Acquisition Loan to the Developers into a long-term development loan and to consolidate it with the Agency's development loan authorized by this Resolution into a single development loan for a total amount not to exceed \$3,289,000; and be it further

**RESOLVED:** That the consolidation of the Site Acquisition Loan shall be contingent on the closing of the Agency's development loan, and shall be contingent on and subject to such other appropriate terms and conditions as the Agency Administrator or his or her designee may establish; and be it further

**RESOLVED:** That the loan shall be for a maximum term of 55 years, with an interest rate of 3 percent per year, with repayment to the Agency from surplus cash flow from the Project and other available funds during the term of the loan with the balance due at the end of the term, or on such other repayment terms and schedule as the Agency Administrator or his or her designee determines are in the best interests of the Agency and the Project; and be it further

**RESOLVED:** That as a condition of the loan, the Agency will require that appropriate restrictions on Project occupancy, rents and operations be recorded against Project improvements; and be it further

**RESOLVED:** That the loan shall be secured by a deed of trust on the Project land and/or improvements; and be it further

**RESOLVED:** That the loan funds will be reserved for a period of no more than 12 months from the date of this Resolution, and the loan shall be contingent on Developers' success in securing remaining commitments for full Project funding, or other assurances of adequate Project funding the Agency Administrator or his or her designee deems sufficient within his or her discretion, within this reservation period; and be it further

**RESOLVED:** That the making of the loan shall be contingent on and subject to such other appropriate terms and conditions as the Agency Administrator or his or her designee may establish; and be it further

**RESOLVED:** That the Agency hereby authorizes the Agency Administrator or his or her designee in his or her discretion to subordinate the priority of the Agency's deed of trust and/or recorded restrictions to a lien or encumbrance of another private or governmental entity providing financial assistance to the Project, if the Agency Administrator or his or her designee determines that (1) an economically feasible alternative method of financing the Project on substantially comparable terms and conditions but without subordination is not reasonably available, (2) the Agency's investment in the Project in the event of default is reasonably protected, and (3) subordination is in the best interests of the Agency; and be it further

**RESOLVED:** That all loan documents shall be reviewed and approved by Agency Counsel for form and legality prior to execution, and copies will be placed on file with the Agency Secretary; and be it further

**RESOLVED:** That the Agency has independently reviewed and considered this environmental determination, and the Agency finds and determines, based on the information provided in the staff report accompanying this Resolution, that this action complies with CEQA

because the Project is exempt from CEQA pursuant to Section 15280 (lower-income housing projects) and Section 15332 (infill development projects) of the CEQA Guidelines; and be it further

**RESOLVED:** That the Agency Administrator or his or her designee shall cause to be filed with the County of Alameda a Notice of Exemption for this Project; and be it further

**RESOLVED:** That the Agency hereby appoints the Agency Administrator and his or her designee as agent of the Agency to conduct negotiations, execute documents, administer the loan, extend or modify the repayment terms, and take any other action with respect to the loan and the Project consistent with this Resolution and its basic purpose.
