RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO AWARD A CONTRACT TO ONE TOYOTA OF OAKLAND, A CORPORATION, TO PROVIDE SIXTEEN (16) 2012 TOYOTA PRIUS HYBRID VEHICLES, IN AN AMOUNT NOT TO EXCEED THREE HUNDRED THIRTY FIVE THOUSAND NINE HUNDRED FIFTY FOUR DOLLARS AND EIGHTY FIVE CENTS (\$335,954.85) PER REQUEST FOR QUOTATION (RFQ) 3571, SPECIFICATION NO. 12-070-06 AND THE GENERAL CONDITIONS THEREFORE ON FILE IN THE PURCHASING DIVISION ACCORDING TO ITS BID FILED WITH THE CITY ON MAY 14, 2012.

WHEREAS, the Purchasing Division formally advertised and bid this contract in accordance with OMC 2.04; and

WHEREAS, on May 14, 2012, the City received two bid to provide sixteen (16) 2012 Toyota Prius hybrid vehicles, submitted in response to Specification No. 12-070-06/RFQ No. 3571; and

WHEREAS, the bid submitted by One Toyota of Oakland, a local corporation, meets all of the requirements contained in Specification No. 12-070-06/RFQ No. 3571 and is deemed the lowest, responsive, responsible bid; now, therefore be it

RESOLVED, That a contract to provide sixteen (16) 2012 Toyota Prius hybrid vehicles, in an amount not-to-exceed three hundred thirty five thousand nine hundred fifty four dollars and eighty five cents (\$335,954.85) in accordance with Specification No. 12-070-06/RFQ No. 3571 and the general conditions therefore on file with the Purchasing Division is hereby awarded to One Toyota of Oakland, a local corporation, according to its bid submitted on May 14, 2012; and be it

FURTHER RESOLVED, That the City Council hereby rejects all other bids received in response to RFQ No. 3571.
