RESOLUTION AUTHORIZING AMENDMENT NO. 5 TO THE AGREEMENT WITH RHL DESIGN GROUP, INC. FOR ADDITIONAL DESIGN AND CONSTRUCTION SUPPORT SERVICES FOR THE ACORN-PRESCOTT NEIGHBORHOOD STREETSCAPE IMPROVEMENTS PROJECT FOR AN AMOUNT NOT TO EXCEED \$50,000 FOR A TOTAL CONTRACT AMOUNT NOT TO EXCEED \$429,000.

WHEREAS, the Acorn-Prescott Neighborhood Improvements project ("project") involves the calming of traffic, improving pedestrian and bicyclist safety, creating a neighborhood identity, and extending the limits of the Oakland Bay Trail; and

WHEREAS, the improvements include sidewalk repairs and accent paving at crosswalks; new bulbouts at major intersections; new street landscaping with trees; ADA ramps; bike lanes; improved street lighting; restriping for two-way traffic on 8th Street; and a landscaped median on Mandela Parkway; and

WHEREAS, the project is being implemented in three phases; and

WHEREAS, the construction of Phase 1 is complete; Phase 2 has been advertised for bids; additional professional services in Phase 3 are needed to provide complete plans, specifications, cost estimates and construction support services; and

WHEREAS, RHL Design Group, Inc. has successfully provided professional services for Phases 1 and 2; and

WHEREAS, funds are available to cover the additional professional services; and

WHEREAS, the grant funding agency requires that certain schedule milestones be met; and in order to meet these schedule requirements, approval of Amendment No. 5 to the consultant agreement is recommended at this time; and

WHEREAS, the City Council finds that this agreement amendment is for services of a professional, scientific or technical nature; and

WHEREAS, the City Council finds that services under this contract will be temporary; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

RESOLVED: That the City Manager is hereby authorized to amend the existing authorization of \$379,000 for RHL Design Group, Inc. to provide additional design and construction support services ("professional services") for an additional amount not to exceed \$50,000 for a total authorization not to exceed \$429,000; and be it

FURTHER RESOLVED: That the City Manager, or his authorized representative, is hereby authorized to approve any subsequent amendments to or extensions of said agreement with the exception of those related to an increase in the total dollar amount of the agreement, provided that such amendments or extensions shall be filed with the City Clerk's Office; and be it

FURTHER RESOLVED: That the contract shall be reviewed and approved by the City Attorney and placed on file in the Office of the City Clerk; and be it

FURTHER RESOLVED: That the City Clerk is hereby directed to post conspicuously forthwith notice of the above award on the official bulletin board in the Office of the City Clerk.
