This action arises out of a traffic enforcement stop on March 21, 2001. Mr. Brown contends that a former Oakland Police Officer pulled her car over without reasonable suspicion and made inappropriate physical contact with her. The former officer denies Ms. Brown's allegations. This settlement is recommended as a compromise of this matter and to avoid a potentially adverse jury verdict should the matter be tried.
