INTRODUCED BY COUNCILMEMBER DAN KALB

**RESOLUTION AUTHORIZING A GRANT NOT TO EXCEED \$6,000 FROM COUNCILMEMBER KALB'S GRAFFITI ABATEMENT MURAL AND GREEN WALL FUNDS TO ARTIST CAROLINE STERN FOR A MURAL ON THE OUTSIDE OF THE ARLINGTON MEDICAL CENTER BLDG. AT 5709 MARKET STREET IN OAKLAND IN COOPERATION WITH MS. CAROLINE WATSON**

**WHEREAS**, on June 27, 2013, the City Council adopted a budget that set aside graffiti abatement funds for murals and green walls for Oakland City Councilmembers to award at their discretion, subject to Council approval, in an effort to address graffiti within their districts; and

**WHEREAS**, the property at the Arlington Medical Center building at 5709 Market street in Oakland is currently in a state of graffiti blight; and

**WHEREAS**, Councilmember Kalb wishes to grant a portion of his Graffiti Abatement Mural and Green Wall Funds to artist Caroline Stern for a mural on the property at the Arlington Medical Center building at 5709 Market Street in Oakland; and

**WHEREAS**, in conformance with City requirements, artist Caroline Stern will provide documentation for the use of the Councilmember's Graffiti Abatement Mural and Green Wall funds, including any permits required and permission from the property owner to install the mural; now, therefore, be it

**RESOLVED:** That the City Council authorizes a grant not to exceed \$6,000 from Councilmember Kalb's graffiti abatement mural and green wall funds to artist Caroline Stern for a mural on the property at the Arlington Medical Center building at 5709 Market Street in Oakland; and be it

**FURTHER RESOLVED:** That the City Administrator is authorized to execute a grant agreement with the artist Caroline Stern for the above purpose, subject to approval as to form and legality by the City Attorney.
