A RESOLUTION HONORING COUNCILMEMBER NATE MILEY FOR TEN YEARS OF OUTSTANDING ACCOMPLISHMENTS AND SERVICE TO DISTRICT SIX AND THE CITY OF OAKLAND

WHEREAS, Councilmember Nathan A. (Nate) Miley was first elected to the Oakland City Council in January 1990; and

WHEREAS, Councilmember Miley served Council District Six, the Oakland City Council and indeed, all the citizens of Oakland for 10 years; and

WHEREAS, Councilmember Miley served the Oakland City Council with exceptional leadership as Chair of the Public Safety Committee, Chair of the Health and Human Services Committee, and Vice Mayor of Oakland; and

WHEREAS, Councilmember Miley served his constituents in District Six with dedication and diligence as evidenced by his re-elections in 1994, 1998, and for the next four years will serve all of East Oakland as County Supervisor District 4; and

WHEREAS, Councilmember Miley served the citizens of Oakland for ten years by creating valuable legislation, policies, and programs, such as Oakland's Deemed Approved Ordinance, the Oakland Pedestrian Safety Project, Operation Beat Feet, Measure 'G', Oakland's Affirmative Action ballot measure, the Alameda County Lead Poisoning Prevention Program, the implementation of many strict blight laws, the Enhanced Street Lighting Program, the formation of, and the City's \$1,000,000 investment in the Community Bank of the Bay, the Neighborhood Traffic Control Program, Oakland's No-Smoking in the Workplace Ordinance, Save Oakland Seniors, the Waterfront Roundtable, Oakland's Creek Protection Ordinance, the Community Restoration Program, opening of the Eastmont Library, the initiation of other legislation and policies on senior services, child care, recycling, fire prevention, community policing, disabled access, and much more; and

WHEREAS, Councilmember Miley served on the Alameda County Transportation Authority, the Congestion Management Authority, Alameda County Lead Poisoning Prevention Program, Joint Powers Authority, and the Waste Management Authority; and

WHEREAS, Councilmember Miley served and worked with the changing leaders of Oakland for ten years, including two Mayors, four City Managers and fifteen Councilmembers; and

WHEREAS, Councilmember Miley served the City Council and citizens of Oakland for ten years by attending approximately **3,340** hours of Committee Meetings and 1,470 hours of City Council Meetings; **now**, therefore be it

RESOLVED: that the Oakland City Council commends Councilmember Nate Miley for these and other great achievements and does hereby proclaim Tuesday, December 12,2000 as Nate Miley Day in the City of Oakland; and be it
