RESOLUTION:

- 1. ACCEPTING, APPROPRIATING, AND AUTHORIZING AGREEMENTS FOR RECEIPT OF GRANT FUNDS FROM THE CORPORATION FOR NATIONAL AND COMMUNITY SERVICES (CNCS-AMERICORPS SENIORS) FOR FISCAL YEAR (FY) 2022-23 IN AMOUNTS NOT TO EXCEED \$337,220 FOR THE SENIOR COMPANION PROGRAM AND \$38,821 FOR THE FOSTER GRANDPARENT PROGRAM; AND**
- 2. AUTHORIZING A CONTRIBUTION FROM THE GENERAL PURPOSE FUND FOR CENTRAL SERVICES OVERHEAD CHARGES IN THE ESTIMATED AMOUNT OF \$39,076 FOR FY 2022-23; AND**
- 3. AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AND APPROPRIATE ADDITIONAL GRANT FUNDS FROM CNCS THAT BECOME AVAILABLE FOR THE SAME PURPOSES WITHIN FY 2022-23.**

WHEREAS, the City of Oakland has been a recipient of grants from the Corporation for National and Community Services (CNCS-AmeriCorps Seniors) for the Senior Companion Program (SCP) since 1977, and the Foster Grandparent Program (FGP) since 1999 and wishes to continue to do so; and

WHEREAS, the City of Oakland SCP and FGP provide meaningful part-time volunteer opportunities for low income older adults who provide supportive assistance to the elderly, children and youth, and their family members; and

WHEREAS, to continue funding low-income senior volunteers for the fiscal year (FY) of July 1, 2022 through June 30, 2023, the City of Oakland desires to apply for, accept, and appropriate grant funds from the CNCS in the amounts of \$337,220 for the SCP and \$38,821 for the FGP, by and through authorized grant agreements, as well as any such additional grant funds that may become available for FY 2022-23; and

WHEREAS, a contribution from the General Purpose Fund (1010) to cover Central Services Overhead charges in an estimated amount of \$39,076 is necessary to maximize benefits to seniors and due to administrative cost restrictions for the grant; now, therefore, be it

RESOLVED: That the City Council hereby accepts, appropriates, and authorizes agreements for receipt of grant funds from CNCS in amounts not to exceed \$337,220 for the SCP, and \$38,821 for the FGP for FY 2022-23; and be it

FURTHER RESOLVED: That grant funds from CNCS will be appropriated to the Federal Action Agency Fund (2120), Senior Companion Program and Foster Grandparent Program Organization (75241), FY 2022-2023 for SCP/FED Project (1005615) and FGP/FED Project (1005619) Empowering Seniors & People with Disability Program (YS14); and be it

FURTHER RESOLVED: That all Central Services Overhead charges associated with these grants, in an estimated amount of \$39,076 for FY 2022-23, will be offset through a contribution from the General Purpose Fund (1010); and be it

FURTHER RESOLVED: That if additional funding becomes available from CNCS for the same purposes for FY 2022-23, the City Administrator or designee is authorized to accept and appropriate those funds to the SCP and the FGP, and to amend the grant agreements with CNCS as may be necessary.
