

INTRODUCED BY HONORABLE MAYOR JEAN QUAN

RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF RICHARD RUEDA, FATIMAH SIMMONS, AND MIQUETTE THOMPSON TO THE COMMISSION ON PERSONS WITH DISABILITIES (MCPD)

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No. 9968 C.M.S., adopted August 5, 1980, and amended by Ordinance No. 11864 C.M.S., adopted March 12, 1996, created the Commission on Persons with Disabilities to address issues germane to accessibility, services and civil rights for persons with disabilities; and the Commission on Persons with Disabilities consists of fifteen (15) members serving three year staggered terms with no more than two consecutive terms, and 51% of Commission members must be persons with disabilities; and

WHEREAS, the Honorable Mayor Jean Quan has appointed Richard Rueda to serve the three-year term previously held by Leticia Escalera, appointed Fatimah Simmons to serve the three-year term previously held by Betty Muholland and appointed Miquette Thompson to complete the three year term previously held by Eva Aguillard, subject to confirmation by the City Council; now therefore be it

RESOLVED: That pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointments to the Mayor's Commission on Persons with Disabilities for the terms set forth below:

Richard Rueda Mayoral appointment to serve the term previously held by Leticia Escalera, beginning June 3, 2012 and ending on June 2, 2015,

Fatimah Simmons, Mayoral appointment to serve the term previously held by Betty Muholland, beginning September 3, 2012 and ending September 2, 2015,

Miquette Thompson, Mayoral appointment to complete the term which began September 3, 2012 and will end September 2, 2015, filling the seat previously held by Eva Aguillard.


