RESOLUTION AUTHORIZING AWARD OF A CONTRACT TO D'ARCY & HARTY CONSTRUCTION, INC. FOR THE IMPROVEMENT OF SANITARY SEWERS IN THE EASEMENT BETWEEN PINEHAVEN AND VALLEY VIEW ROADS (PROJECT NO. C200610) FOR THE AMOUNT OF SEVENTY-ONE THOUSAND FIVE HUNDRED DOLLARS (\$71,500)

WHEREAS, on February 9, 2004, five bids were received by the Office of the City Clerk of the City of Oakland for the improvement of Sanitary Sewers in the easement between Pinchaven and Valley View Roads (Project No. C200610); and

WHEREAS, the improvement of Sanitary Sewers in an easement between Pinehaven and Valley View Roads (Project No. C200610), is consistent with the Mayor/City Council Goal and Citywide Objective to maintain and enhance Oakland Physical Assets; and

WHEREAS, D'arcy & Harty Construction, Inc., a certified SLBE, bidding as a prime is the lowest responsible bidder for the project and has met the SLBE requirements; and

WHEREAS, there are sufficient funds in the project budget for the work, and the project budget includes \$96,750 (Fund 3100, Project C200610, Account 57417) for the construction work; the engineer's estimate for the work is \$96,750; and

WHEREAS, the City lacks the equipment and qualified personnel to perform the necessary work; and

WHEREAS, the City Council finds and determines that the performance of this contract is in the public interest because of economy; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive services; now, therefore, be it

RESOLVED: That the contract for the Improvement of Sanitary Sewers in an easement between Pinehaven and Valley View Roads (Project No. C200610) is hereby awarded to D'arcy & Harty Construction, Inc., in accordance with the terms of its bid therefore, dated February 9, 2004 for the amount of seventy-one thousand five hundred dollars (\$71,500); and be it

FURTHER RESOLVED: That the plans and specifications prepared by the Director of Public Works for this project are hereby approved; and be it

FURTHER RESOLVED: That the amount of the bond for faithful performance, \$71,500 and the amount for a bond to guarantee payment of all claims for labor and materials furnished and for the amount due under the Unemployment Insurance Act, \$71,500 with respect to such work are hereby approved; and be it

FURTHER RESOLVED: That the City Manager is hereby authorized to enter into a contract with D'arcy & Harty Construction, Inc., on behalf of the City of Oakland and to execute any amendments or modifications of said contract within the limitations of the project specifications; and be it

FURTHER RESOLVED: That all other bids are hereby rejected; and be it

FURTHER RESOLVED: That the contract shall be reviewed and approved by the City Attorney and placed on file in the Office of the City Clerk; and be it

FURTHER RESOLVED: That the approval of this resolution requires a two-thirds vote of the Council members.
