Dear President De La Fuente and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and recommends settlement of the above-entitled claims of Joseph Parker, Nathan Caveness, Akua Franklin, Elias Margain, James Ollier, Franck Williams and Charles Roberson for a total sum of Three Hundred Twenty Four Thousand Dollars and No Cents (\$324,000.00) of which the City would pay only Twenty Four Thousand Dollars and No Cents (\$24,000.00). These seven (7) plaintiffs alleged that they were falsely arrested and convicted of criminal charges on the basis of perjured testimony by the arresting officers. Following delivery of independent evidence supporting the plaintiffs' contention that they were convicted on the basis of perjured testimony, the District Attorney reviewed and subsequently dismissed the criminal cases. The City Attorney's Office and the City's insurance carriers have conditionally agreed to globally settle these seven (7) cases for a total sum of Three Hundred Twenty Four Thousand Dollars and No Cents (\$324,000.00).

Because one of the plaintiffs, Charles Roberson, was arrested and incarcerated during a time when the City did not have insurance, the City's insurance carriers have refused coverage for that one case. City Council approval of payment of this Twenty Four Thousand Dollars and No Cents (\$24,000.00) is a necessary condition of the global settlement of all of the remaining cases. This case was discussed in closed session October 5, 2004.
