RESOLUTION AWARDING A CONTRACT TO BRICKER-MINCOLLA UNIFORM COMPANY, A SMALL LOCAL BUSINESS, IN AN AMOUNT NOT TO EXCEED THREE HUNDRED FOUR THOUSAND, SEVEN HUNDRED SIXTY-FOUR DOLLARS (\$304,764.00) PER YEAR FOR AN AGGREGATED AMOUNT NOT TO EXCEED \$609,528.00 FOR THE CONTRACT PERIOD OF JULY 1, 2013 TO JUNE 30, 2015, TO PROVIDE SOFT BODY ARMOR VESTS, TO THE CITY OF OAKLAND IN ACCORDANCE WITH SPECIFICATION NO. 13-680-08/REQUEST FOR QUOTE (RFQ) NO. 4444 AND THE GENERAL CONDITIONS THEREFOR ON FILE IN PURCHASING ACCORDING TO ITS BID FILED WITH THE CITY ON FEBRUARY 25, 2013.

WHEREAS, four bids to provide soft body armor were submitted in response to the advertised Specification No. 13-680-08/RFQ No. 4444 and opened on February 25, 2013; and

WHEREAS, the bid submitted by Bricker-Mincolla meets all of the requirements contained in Specification No. 13-680-08/RFQ No. 4444 and is the lowest, responsive, responsible bid; and

WHEREAS, the bids submitted by Adamson Police Products, Proforce and L C Action meet the minimum specification but were not the lowest bid in response Specification No. 13-680-08/RFQ No. 4444; and

WHEREAS, Funds will be encumbered by the requesting department and are available in the General Purpose Fund (1010), the Police Training Unit Organization (103430), Police Training Program (PS09) and Clothing Account (52912); now be it

RESOLVED: That a contract for the purchase of soft body armor vests in an amount not-to-exceed three hundred four thousand, seven hundred sixty-four dollars (\$304,764.00) per year for the contract period of July 1, 2013 to June 30, 2015, in accordance with Specification No. 13-680-08/RFQ No. 4444 and the general conditions therefor on file with Purchasing is hereby awarded to Bricker-Mincolla Uniform Company, a small local business, the lowest, responsible and responsive bidder according to its bid submitted on February 25, 2013; and be it

FURTHER RESOLVED, That the City Council hereby rejects all other bids submitted in response to RFQ No. 4444; and be it

FURTHER RESOLVED, That the contract shall be approved for form and legality by the City Attorney and copies shall be on file in the City Clerk's Office.


