

**RESOLUTION ON BEHALF OF THE CITY OF OAKLAND
RATIFYING CALIFORNIA EMERGENCY MANAGEMENT
AGENCY (CAL-EMA) FUNDED GRANTS TO CALIFORNIA
SCHOOL AGE CONSORTIUM IN THE AMOUNT OF \$13,000.00,
2) LEADERSHIP EXCELLENCE IN THE AMOUNT OF \$75,250.00
AND 3) GROWTH SECTOR COMPANY IN THE AMOUNT OF
\$27,500.00, FOR YOUTH SERVICES PROVIDED IN CONNECTION
WITH THE OAKLAND HIGH SCHOOL CAREER PATHWAY
AND COMMUNITY COLLABORATIVE AT FREMONT HIGH
SCHOOL AND CASTLEMONT HIGH SCHOOL**

WHEREAS, City Council adopted Resolution No. 82799 C.M.S., June 1, 2010, from Mayor Ron Dellums to provide the City Administrator with the authority to apply for, accept and appropriate the Cal-EMA grant in the amount of three hundred eighty-two thousand six hundred nine dollars to be used for a two-year program to reduce violence and gang-related activities in Oakland called the High School Career Pathways and Community Collaborative; and

WHEREAS, the High School Career Pathways and Community Collaborative, provides training, employment and a complete pathway through high school, college, graduate school and full-time teaching and school administration positions that reduces violence and gang-related activities; and

WHEREAS, the Council previously authorized Cal-EMA grants to Spanish Speaking Citizens Foundation (\$226,241.00), Laney College (\$10,000.00), Private Industry Council (\$26,000.00) and funds to cover Oakland's fiscal management costs (\$19,639.00) in connection with the High School Career Pathways and Community Collaborative; and

WHEREAS, the Council wishes to ratify Cal-EMA grants made to California School Age Consortium in the amount of \$13,000.00, Leadership Excellence in the amount of \$75,250.00, and Growth Sector Company in the amount of \$27,500.00 in connection with the High School Career Pathways and Community Collaborative; now therefore

RESOLVED, That the City Council authorizes and ratifies Cal-EMA grants made to California School Age Consortium in the amount of \$ 13,000.00, Leadership Excellence in the amount of \$75,250.00, and Growth Sector Company in the amount of \$27,500.00 in connection with the High School Career Pathways and Community Collaborative; and be it

FURTHER RESOLVED, That said agreements shall be approved as to form and legality by the Office of the City Attorney and placed on file in the Office of the City Clerk.


