RESOLUTION AWARDING A CONTRACT TO WILLIE ELECTRIC SUPPLY CO., DBA SAN LEANDRO ELECTRIC SUPPLY, THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, FOR ELECTRICAL SUPPLIES IN THE AMOUNT NOT-TO-EXCEED \$150,000 PER YEAR FOR A THREE (3) YEAR TERM, OCTOBER 1, 2019 TO SEPTEMBER 30, 2022, WITH TWO (2) ONE-YEAR OPTIONS TO EXTEND THE CONTRACT IN AN AMOUNT NOT-TO-EXCEED \$150,000 PER YEAR FOR A TOTAL CONTRACT AMOUNT OF \$750,000 OVER A FIVE-YEAR TERM IN ACCORD WITH SPECIFICATION NO. 19-285-00/RFQ 160513 AND CONTRACTOR'S BID

WHEREAS, the Oakland Public Works Department (OPW), Bureau of Maintenance and Internal Services (BMIS), Facilities Services Division maintains all City facilities; and

WHEREAS, the City initiated the request for quotation (RFQ) to select the most qualified lowest responsive and responsible bidder of electrical goods and supplies for City facilities; and

WHEREAS, staff recommends that the City Council adopt a resolution authorizing the City Administrator to award a contract to Willie Electric Supply Co., dba San Leandro Electric Supply, the lowest responsive and responsible bidder, for electrical supplies in the amount not-to-exceed \$150,000 per year for a three (3) year term, October 1, 2019 to September 30, 2022, with two (2) one-year options to extend the contract in an amount not-to-exceed \$150,000 per year for a total contract amount of \$750,000 over a five-year term, in accord with Specification No. 19-285-00/RFQ 160513 and Contractor's Bid; and

WHEREAS, the City Council finds that the agreement with Willie Electric Supply Co., dba San Leandro Electric Supply are of a professional nature, in the public interest because of economy or better performance and shall not result in the loss of employment or salary by any person having permanent status in the competitive service; and

WHEREAS, the funds for this contract are budgeted in the FY 2019-2020 Facilities Services Fund (4400), and any future fiscal year funding for this contract is subject to Council approval; now, therefore, be it

RESOLVED: That the City Council hereby award a contract to Willie Electric Supply Co., dba San Leandro Electric Supply, the lowest responsive and responsible bidder, for electrical supplies for all City facilities in an amount not-to-exceed \$150,000

per year, for three (3) year term, October 1, 2019 to September 30, 2022, in accord with Specification No. 19-285-00/RFQ 160513 and Contractor's Bid; and be it

FURTHER RESOLVED: That the City Administrator or designee is hereby authorized to extend the agreement, annually, up to two (2) one-year periods in an amount not-to-exceed \$150,000 per year for a total contract amount of \$750,000 over a five-year term; and be it

FURTHER RESOLVED: That the City Administrator or designee is hereby authorized to extend the contract with Willie Electric Supply Co., dba San Leandro Electric Supply on a month-to-month basis after the initial extension options are exhausted while a process for a new contract is completed; and be it

FURTHER RESOLVED: That the contract and amendments authorized hereunder shall be reviewed and approved by the City Attorney for form and legality and shall be placed on file in the office of the City Clerk.


