

**RESOLUTION APPOINTING PEGGY SIMMONS AS A MEMBER OF
THE LIBRARY ADVISORY COMMISSION**

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No 8064CMS creates the Library Advisory Commission whose members are nominated by the Mayor and approved by the City Council; and

WHEREAS, Ordinance No 11730 CMS specifies that members of the Library Advisory Commission are to serve three year terms which are to be staggered so that some appointments will expire every year and appointments to fill a term of office are only to be for the remainder of that term now therefore be it

WHEREAS, the Honorable Mayor Ronald V. Dellums has appointed Peggy Simmons to serve a three year term on the Library Advisory Commission, subject to confirmation by the City Council; now therefore be it

RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of Peggy Simmons to the Library Advisory Commission, for a three year term beginning November 13, 2009 and ending November 12, 2012 filling the seat previously held by Sue Yascolt.
