SUMMARY

At the October 27, 2009 Finance and Management Committee meeting, the Committee directed staff to come back with a revised Ordinance that included the technical corrections necessary for accuracy and to explain the addition of two classifications to the City Auditor's office. This report provides the requested information.

FISCAL IMPACT

There are no fiscal impacts associated with this report. The changes to the Salary Ordinance serve only to update and revise the City's job classification system. If departments wish to add positions in their budgets, they are required to submit those changes through the City Council budget approval process.

BACKGROUND

The Part Time (PT) and Permanent Part Time (PPT) classifications were created as the result of a survey of department needs conducted by the Department of Human Resources Management. Some of the work is currently being performed by employees in Temporary Contract Service Employee classifications. Creation of these PT and PPT classifications will assist the City's ongoing efforts to manage and reduce the use of Temporary Contract Service Employees and will provide departments with additional flexibility in meeting their staffing needs.
