**CITYWIDE CURB RAMPS AND SIDEWALK CONSTRUCTION 2023-2025**

**Description:**

The proposed work consists primarily of field-fit curb ramp construction per City of Oakland Standard Curb Ramp Plans. Upon field layout by City engineer or inspector, Contractor is responsible to achieve ADA compliant ramps. Specific scope includes 240 field-fitted curb ramp installations; 300 SF of retrofitting detectable warning dome pavers; 1,500 LF of concrete curb replacement; 2,250 SF of concrete gutter replacement; 4,000 SF of concrete driveway replacement; approximately 25,000 SF of concrete sidewalk replacement; 5,000 SF of tree root pruning; and other ancillary work shown in the project bid documents.

**Bids Due:** Thursday, April 18, 2024, by 2:00 PM. ***Bids may either be uploaded into the City's iSupplier online procurement system, or may be mailed or hand delivered to the City Clerk at 1 Frank H. Ogawa Plaza, Room 104, Oakland, CA 94612 prior to the bid due date and time.***

Bidders must be registered with iSupplier to submit bids online. New users should register at least three days prior to bid deadline. Bidders may access iSupplier by going to the following web address.

**Department of Industrial Relations (DIR):**

1. No contractor or subcontractor may be listed on a bid proposal for a public works project unless registered with the DIR pursuant to Labor Code Section 1725.5 [with limited

exceptions from this requirement for bid purposes only under Labor Code Section 1771.1(a)].

2. No contractor or subcontractor may be awarded a contract for public work on a public works project (awarded on or after April 1, 2015) unless registered with the DIR pursuant to Labor Code section 1725.5.
3. This project is subject to compliance monitoring and enforcement by the DIR.
4. The prime contractor must post job site notices prescribed by regulation.
5. Assembly Bill 219 requires companies hauling or delivering ready-mix concrete to register with the DIR as a public works contractor.
