

INTRODUCED BY COUNCIL PRESIDENT PRO TEM IGNACIO DE LA FUENTE

### RESOLUTION CONFIRMING RE-APPOINTMENT OF BRUCE NYE TO THE BUDGET ADVISORY COMMITTEE

**WHEREAS**, Ordinance No. 74826 C.M.S. creates the Budget Advisory Commission; and

**WHEREAS**, appointments to the City's Boards and Commissions, including the Budget Advisory Committee, are governed by Section 601 of the Oakland City Charter; and

**WHEREAS**, the Budget Advisory Committee consists of 15 members, one (1) apiece recommended by each of the eight City Councilmembers, one (1) appointed by the Mayor to act as Chairperson, three (3) appointed by the Mayor from a list of 12 recommendations from the Chamber of Commerce, two (2) recommended by the Chairperson of the Finance and Management Committee, and one (1) recommended by the Chairperson of the Community and Economic Committee, each serving no more than two consecutive two-year terms and each subject to the approval of the City Council; and

**WHEREAS**, Section 601 states that Members of boards and commissions shall be appointed by the Mayor subject to confirmation by the Council, however, if the Mayor does not submit for confirmation a candidate to fill the vacancy within 90 days of the date the vacancy first occurred, the Council may fill the vacancy; and for purposes of this Section, a seat filled by a holdover appointment will be considered vacant as of the expiration of the holdover's prior term of office; and

**WHEREAS**, Bruce Nye was appointed to the Budget Advisory Board as the Representative of the Finance and Management Committee Chair for the term beginning on May 26, 2009 and ending on May 25, 2011, thereby creating a vacancy; and

**WHEREAS**, the Mayor has failed to submit a candidate to fill the Finance and Management Committee Chair Representative seat vacancy and it has been well over 90 days since the vacancy first occurred on May 25, 2011 and, accordingly, pursuant to Section 601, Council President Pro Tem Ignacio De La Fuente hereby nominates Bruce Nye to be re-appointed to the Budget Advisory Committee to the seat he previously held, one of the Representatives of the Finance and Management Committee; now, therefore, be it

**RESOLVED:** That pursuant to City Charter section 601 and on the nomination of Council President Pro Tem Ignacio De La Fuente, the City Council hereby re-appoints Bruce Nye to the Budget Advisory Committee, one of the Representatives of the Finance and Management Committee, to serve the term beginning May 26, 2011 and ending May 25, 2013, filling the seat he previously held.
