Pursuant to Section 401 of the Charter, the City Attorney has prepared and recommends settlement of the above-entitled matter arising from an incident on January 28, 2004, in which plaintiff Donte Hooker sustained a broken jaw during an altercation with an OPD officer.

Due to the risk of an adverse jury verdict under the circumstances, settlement is recommended in the amount of Ten Thousand Dollars and No Cents (\$10,000.00), to be made payable to Donte Hooker and John L. Burris, Esq., his attorney.
