**RESOLUTION HONORING MR. H. MAHLON HARMON FOR NINETEEN (19) YEARS
OF DEDICATED AND DISTINGUISHED SERVICE TO THE CITY OF OAKLAND
AND CONGRATULATING HIM ON HIS RETIREMENT.**

WHEREAS, H. Mahlon Harmon, relocated to Oakland, CA in 1955 and graduated from Oakland Technical High School in 1958, and;

WHEREAS, H. Mahlon Harmon upon graduation from San Francisco State University, began his career in civic service when he was selected to participate in the first class of the National Urban Fellows Program, and chosen to do an internship with Carl B. Stokes, former Mayor of Cleveland, OH and;

WHEREAS, H. Mahlon Harmon in 1974, became the executive director Youth For Service in San Francisco, which won a national award from the U.S. Dept. of Labor for its innovative programs, and;

WHEREAS, H. Mahlon Harmon began his employment with the City of Oakland in 1988 and established the Graffiti Abatement Program, which won an award during its first year of operation for its achievements; and,

WHEREAS, H. Mahlon Harmon, was appointed by Councilmember Larry Reid in 1998 to serve on the Planning and Oversight Committee for KidsFirst!, served as co-chair for two years, worked on Councilmember Reid's Small Business Symposium and developed all of the panels and workshops for the first six years, and;

WHEREAS, H. Mahlon Harmon was one of the original organizers for the establishment of IFPTE Local 21 Chapter for City employees and served as the Political Action Coordinator, and,

WHEREAS, H. Mahlon Harmon in 2007 served as convener of Mayor Ronald V. Dellums' Task Force on City Government during the implementation phase, and,

WHEREAS, H. Mahlon Harmon during his career developed Community Development Block Grant contracts, conducted training for CDBG District Board Members, and served as Masters of Ceremonies at Employee of the Year ceremonies as well as numerous other City and Union sponsored events, and,

WHEREAS, H. Mahlon Harmon, in April 2008, announced his retirement from the City of Oakland to enjoy his family, traveling, and his passion for mentoring at-risk African-American youth, now, therefore, be it:

RESOLVED: That the elected officials, staff and citizens of Oakland hereby recognize H. Mahlon Harmon for his outstanding service and many contributions to the City of Oakland, which exemplify excellence in the workplace; and be it:
