**RESOLUTION HONORING MONICA LAMBOY FOR ELEVEN YEARS OF DISTINGUISHED SERVICE TO THE CITIZENS OF OAKLAND**

**WHEREAS**, Monica Renee Lamboy began her service to the City of Oakland as a Planning Intern in 1990 while a graduate student at the University of California, Berkeley, following completion of an undergraduate degree in Civil Engineering from Princeton University; and

**WHEREAS**, upon completion of her Masters degree in City and Regional Planning at the University of California, Berkeley, she was appointed in October 1992 as a Planner II in Comprehensive Planning and she worked countless hours on the City Council redistricting plan, and also developed neighborhood policies for the Oakland General Plan update that addressed issues of housing density, affordable housing, neighborhood commercial areas and institutional issues; and

**WHEREAS**, Monica Lamboy was appointed to the City Manager Analyst position in 1996 and during her tenure, prepared and implemented high profile ordinances regulating billboards and crafted restrictions on alcohol and tobacco advertising, led enforcement efforts to reduce criminal and nuisance activity at hotels and motels in Oakland and represented the City Manager on the Oakland Base Reuse Authority; and

**WHEREAS**, in 1998 Monica Lamboy was promoted as Assistant to the City Manager and managed the development and implementation of the innovative Performance Planning and Appraisal System citywide, including training of over 450 supervisors and managers and also worked on special assignments with the Oakland Police Department and the Oakland Unified School District; and

**WHEREAS**, in 2000 Monica Lamboy was appointed to the Chief Administrative Officer position in the Community and Economic Development Agency and in the past three years has led agency-wide efforts to improve customer service, reduce expenditures, dramatically improve the operating procedures and develop two program budgets; and

**WHEREAS**, in 2002 her exceptional innovativeness and drive resulted in her appointment as co-leader of the Moving Oakland Forward! strategic planning process that resulted in the adoption of several key initiatives by the City Manager and City Council and in her being recognized as Employee of the Year for 2002; and

**WHEREAS**, in addition to her professional work she has made time to volunteer in her community as a bilingual reading tutor through the HEROES school literacy program and with her neighborhood community association; and

**WHEREAS**, Monica Lamboy's unwavering pursuit of excellence and public services has led her to pursue personal and professional development for up to a year working in South America in a program sponsored through USAID and the International City Management Association; now therefore be it

**RESOLVED**: That the Mayor, City Council and City Manager do hereby commend Monica Lamboy for her eleven years of incomparable commitment to excellence and distinguished public service and contributions to the Oakland community; and, be it

**FURTHER RESOLVED**: That a copy of this resolution, suitably inscribed, be presented to Monica Lamboy with the compliments of the Mayor, City Council and City Manager as a token of their appreciation and high esteem, and with best wishes for an illustrious and remarkable professional career in city management and community service.
