RESOLUTION APPROPRIATING \$275,000 IN INTEREST INCOME EARNED TO THE OAKLAND FUND FOR CHILDREN AND YOUTH; AUTHORIZING THE APPROPRIATION OF \$275,726 FROM THE UNSPENT AND AVAILABLE PROJECT BALANCE OF PROJECT P203730 FOR THE OAKLAND FUND FOR CHILDREN AND YOUTH (FUND 1780); AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE PROFESSIONAL SERVICES CONTRACTS BETWEEN THE CITY OF OAKLAND AND VARIOUS NON-PROFIT AND PUBLIC AGENCIES TO PROVIDE DIRECT SERVICES FOR CHILDREN AND YOUTH UNDER THE CITY'S OAKLAND FUND FOR CHILDREN AND YOUTH FOR FISCAL YEAR 2003-2004 IN AN AMOUNT NOT TO EXCEED \$7,965,449.

WHEREAS, Measure K/Kids First! Initiative established the Oakland Fund for Children and Youth ("OFCY") to help young people grow to become healthy, productive, and honorable adults; and

**WHEREAS**, for fiscal year 2003-2004, the City Council has appropriated \$7,436,723 of the total OFCY revenue to be awarded to qualified organizations providing direct services to children and youth as outlined in the Strategic Plan; and

WHEREAS, any interest earned and amounts unspent or uncommitted by the fund at the end of any fiscal year are to be added to the fund balance for OFCY as specified in the Measure K/Kids First! Charter Amendment; and

WHEREAS, interest income earned from March 1, 2002 to February 28, 2003 totaled \$275,000, of which 5% (\$13,750) is available for administration; 3% (\$8,250) is available for evaluation, and 92% (\$253,000) is available for grants according to the terms of Measure K/Kids First Charter Amendment; and

WHEREAS, the interest appropriation in FY99/00, for services provided in FY00/01 that are now completed, results in an unspent project balance of \$275,726 in P203730 and these funds are available for allocation to grants; and

WHEREAS, the City Council wishes to appropriate the interest income of \$275,000, and to allocate the specified portion of said funds to 1) respondents to the November 2002 request for proposals, 2) administration, and 3) evaluation, according to the terms of Measure K/Kids First! Charter Amendment; and,

WHEREAS, the Request for Proposals from private non-profit and public entities to provide services for the period of July 1, 2003 through June 30, 2004 was released in November, 2002; and

WHEREAS, the Planning and Oversight Committee ("POC"), created by Charter Amendment in 1996, and OFCY staff and trained reviewers have evaluated 124 proposals for the Oakland Fund for Children and Youth in accordance with the criteria in the Request for Proposals; and

**WHEREAS**, in September 2001, the City Council approved the second OFCY Strategic Plan with four priority areas; and

WHEREAS, the POC has complied with the goals, objectives and service priorities in the Strategic Plan; and

**WHEREAS**, the POC recommends the following 56 agencies for funding in the amounts specified below:

Now therefore, be it

**RESOLVED**: That the City Council hereby appropriates \$275,000 in interest earned and allocates \$253,000 in interest income to Fund 1780 Org. 90521 for grants for direct services to children and youth and \$22,000 to Fund 1780 Department of Human Services Org. 78251 for administration and evaluation of the Oakland Fund for Children and Youth, and revenues will be increased by these same amounts to the same fund and organization numbers; and, be it further

**RESOLVED:** That the City Council approves the appropriation of unspent monies from prior years in the amount of \$275,726 from the unspent project balance in P203730 to Oakland Fund for Children and Youth Fund 1780 Org. 90521 (non-departmental funds) for grants for FY 03-04; and, be it further

**RESOLVED:** That the City Manager is authorized to execute 56 agreements with the aforementioned service providers in the amounts specified above and additional agreements with the aforementioned wait listed agencies using funds available in the amounts specified or for the portion thereof that becomes available to provide services to children and youth in the City of Oakland in an amount not to exceed \$7,965,449, and is authorized to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, modifications, payment requests, and related actions which may be necessary in accordance with the basic purpose of this resolution; and, be it further

**RESOLVED:** That said agreement(s) shall be approved as to form and legality by the Office of the City Attorney and placed on file in the Office of the City Clerk.
