Homeland Security's Assistance to Firefighters Grant Program, Fire Prevention and Safety Grants for the Provision of Training Materials and Staffing of the Oakland Fire Department's Risk Watch Program

SUMMARY

A resolution has been prepared authorizing the City Administrator to apply for, accept and appropriate up to \$250,000 from the U.S. Department of Homeland Security's Assistance to Firefighters Grant Program, Fire Prevention and Safety Grants (FPSG), for the provision of training materials and staffing of the Oakland Fire Department's Risk Watch Program.

FPSG is a one-year grant that funds fire prevention activities designed to reach high-risk target groups and mitigate injuries and incidences of death caused by fire and related hazards. The Oakland Fire Department is proposing a Risk Watch Program that will provide fire and injury prevention training to students in grades K-3. Staff is currently working to finalize the cost and develop a budget for the program, but it is estimated that the costs will not exceed \$312,000.00. The requested grant funding will not exceed \$250,000. There is a twenty percent (20%) matching requirement that will not exceed \$62,000.00. The application for grant funds will be submitted subject to Council approval.

FISCAL IMPACT

Authorizing this resolution allows the City to apply for, accept and appropriate grant funds; in an amount not to exceed \$250,000; from the FPSG for the provision of training materials and staffing of the Oakland Fire Department's Risk Watch Program. The Fire Department will use existing resources in its FY 2008-09 baseline budget; in an amount not to exceed \$62,000; for the matching funds - provided the FY 2008-09 budget is adopted as shown in the FY 2007-09 Policy Budget. The grant funds will be appropriated to and matching funds drawn from the U.S. Department of Homeland Security Fund (2124), Fire Prevention Bureau (20311), various accounts as approved, project to be determined, and the Fire Prevention Bureau program (PS23). The Fire Prevention Unit will provide project management and oversee implementation of the Risk Watch Program. OFD Safety and Liability Division grants and contract staff will be responsible for administering this agreement and ensuring that all requirements set forth in the agreement are met.

BACKGROUND

Injuries are the number one health risk for children under the age of 14. It is estimated that each year in the United States more than 7,000 children are killed by unintentional injuries and another 50,000 are permanently disabled. An additional 13 million children are injured seriously enough to require medical attention. In Alameda County the death rate for children ages 0-17 is 8.9 per 100,000. Significantly, unintentional injuries are the number one cause of death for children ages 0-17. Moreover, in most cases, these injuries and/or deaths are preventable. With proper education, children can learn to prevent injuries that cause death and disabilities.

KEY ISSUES AND IMPACT

In light of the number of child deaths as a result of unintentional injuries, it is critical that public education programs be expanded to include effective training to teach children to prevent such injuries.

Unintentional injuries include:

- Vehicle accidents
- Drownings
- Fires
- Firearm discharges
- Falls
- Poisonings

These types of injuries are preventable when effective training programs such as the proposed OFD Risk Watch Program, are utilized to teach children how to promote their own personal safety and well-being, as well as that of their friends, family and community. The Risk Watch curriculum is targeted to the prevention of unintentional injuries. Risk Watch (see attached brochure) was developed through a partnership between the National Fire Protection Association (NFPA) and other safety industry leaders. Using its tested format and methodology, OFD will tailor the program to meet the needs of children in grades K-3 throughout Oakland.

The Fire Prevention Division has a public education component that has an established positive relationship with local businesses, community agencies and the Oakland Unified School District (OUSD). Through these relationships OFD staff currently provides fire prevention training to children in elementary and middle schools throughout the OUSD. This relationship will be expanded and used as a vehicle to introduce Risk Watch to OUSD students in grades K-3.

PROJECT DESCRIPTION

Risk Watch is a comprehensive injury prevention program for children in grades K-3. The Oakland Fire Department will create a targeted outreach and education program for youth in order to prepare them for emergencies in their homes and schools, foster positive relationships with the City of Oakland, the Fire Department and their surrounding community.

The program targets motor vehicle safety, fire and burn prevention, choking, suffocation and strangulation prevention, poisoning prevention, falls prevention, firearms injury prevention, bike and pedestrian safety and water safety. Risk Watch gives children an opportunity to learn about injury prevention, apply that knowledge in practice situations, and develop the attitude and motivation to make the right choice in risky situations. Students are actively involved in exercises that teach awareness and injury prevention. These exercises include creating a safety trade show, analyzing risky behaviors through story-telling, role-playing and songs. Essential to its success is that the curriculum promotes not only personal safety, but encourages students to be conscious of the safety of their friends, family and community.

SUSTAINABLE OPPORTUNITIES

<u>Economic-</u> Reducing injuries to children has a significant economic impact that benefits City, County, State and Federal governments who respond to, treat and pay for medical services of injured children.

Environmental- There are no environmental issues associated with this report.

<u>Social Equity-</u> The proposed program teaches children to be aware of their safety and that of their friends, family and community. This training has the potential to significantly decrease the risk of injury and death as a result of unintentional injuries.

DISABILITY AND SENIOR ACCESS

There are no disability or senior access issues associated with this report.

RECOMMENDATION(S) AND RATIONALE

Staff recommends approval of the proposed resolution authorizing the City Administrator to apply for, accept and appropriate up to \$250,000 from the U.S. Department of Homeland Security's Assistance to Firefighters Grant Program, Fire Prevention and Safety Grants (FPSG) for the provision of training materials and staffing of the Oakland Fire Department's Risk Watch Program.

ACTION REQUESTED OF THE CITY COUNCIL

Staff requests the City Council to approve this report and a resolution authorizing the City Administrator to apply for, accept and appropriate up to \$250,000 from the U.S. Department of Homeland Security's Assistance to Firefighters Grant Program, Fire Prevention and Safety Grants for the provision of training materials and staffing of the Oakland Fire Department's Risk Watch Program.

WHERAS, unintentional injuries are the number one cause of death for children ages 0-17; and

WHEREAS, in Alameda County the death rate for children ages 0-17 is 8.9 per 100,000; and

WHEREAS, training is essential to the reduction of death and injuries of children as a result of unintentional injuries; and

WHEREAS, FPSG provides grant funds to Fire Department's for the development and implementation of training programs that heighten awareness of personal safety and potentially reduce the number of injuries and death; and

WHEREAS, established relationships and partnerships with the public and private sector result in mutual benefits and affords the opportunity to work toward common goals; and

WHEREAS, the Oakland Fire Department has established effective partnerships with local agencies, businesses and Oakland Unified School District (OUSD) to provide training to children ages 0-17; and

WHEREAS, Risk Watch is endorsed by the National Fire Protection Association (NFPA) and other safety industry leaders and Fire Prevention staff will tailor it to meet the specific needs of students in grades K-3 throughout OUSD; and

WHEREAS, the Fire Department will use existing resources in its FY 2008-09 baseline budget; in an amount not to exceed \$62,000; for the matching funds - provided the FY 2008-09 budget is enacted as adopted in the FY 2007-09 Policy Budget; and

WHEREAS, grant funds that will not exceed \$250,000 will be appropriated to and matching funds drawn from the U.S. Department of Homeland Security Fund (#2124), Fire Prevention Bureau (#20311), various accounts as approved, project to be determined, and the Fire Prevention Bureau program (#PS23); and

WHEREAS, all purchases of goods and/or services associated with implementing the Risk Watch Program will be conducted in compliance to the City of Oakland's purchasing polices; now, therefore be it

RESOLVED: That the City Council of the City of Oakland authorizes the City Administrator to apply for, accept and appropriate up to \$250,000 from the U.S. Department of Homeland Security's Assistance to Firefighters Grant Program, Fire Prevention and Safety Grants (FPSG) for the provision of training materials and staffing of the Oakland Fire Department's Risk Watch Program; and be it
