AN ORDINANCE AMENDING THE MASTER FEE SCHEDULE (ORDINANCE NUMBER 9336, AS AMENDED) TO ESTABLISH A MEDICAL CANNABIS CULTIVATION PERMIT APPLICATION FEE OF \$5,000 AND AN ANNUAL REGULATORY FEE OF \$211,000 FOR PERMITTED MEDICAL CANNABIS CULTIVATION FACILITIES.

WHEREAS, on July 27th, 2010 the City Council passed an ordinance amending Title 5 of the Oakland Municipal Code, Entitled Business Licenses and Regulations, To Add Chapter 5.81, Pertaining to Medical Cannabis Cultivation Facility Permitting; and

WHEREAS, the fee additions proposed herein have been justified in a report to the City Council dated July 27th 2010 entitled in part "... [A]n ordinance permitting four (4) medical cannabis cultivation, manufacturing and processing facilities as a business permit through the City Administrator's Office; and

WHEREAS, it is the City Council's intention to ensure that the city has the capacity and resources to permit, regulate and monitor Medical Cannabis Cultivation, Manufacturing and Processing facilities permitted under the above referenced ordinance

WHEREAS, the City council finds and determines that establishing a medical cannabis cultivation permit application fee of \$5,000 and an annual regulatory fee of \$211,000 for permitted medical cannabis cultivation facilities are necessary to reimburse the City for the costs of performing the various municipal and regulatory functions associated with Chapter 5.81; and

WHEREAS, a Public Hearing was held on October 19th, 2010, to review the proposed fees; now therefore

THE COUNCIL OF THE CITY OF OAKLAND DOES ORDAIN AS FOLLOWS:

Section 1. The Master Fee Schedule as set forth in Ordinance Number _____ CMS, as amended is hereby amended to modify and establish a medical cannabis cultivation permit application fee of \$5,000 and an annual regulatory fee of \$211,000 for permitted medical cannabis cultivation facilities

Section 2. This ordinance shall be effective upon approval by the Council of the City of Oakland, November 1, 2010.
