

**AN ORDINANCE AMENDING THE SALARY SCHEDULE OF ORDINANCE NO. 12187 (THE SALARY ORDINANCE) TO INCREASE THE SALARIES OF EMPLOYEES BY 4% FOR FISCAL YEAR 2006-07 AND 2007-2008, PURSUANT TO THE RECENTLY APPROVED MEMORANDUM OF UNDERSTANDING, FOR THE DEPUTY CITY ATTORNEY V AND SPECIAL COUNSEL ASSOCIATION AND TO INCREASE THE SALARIES OF EMPLOYEES BY 4% FOR FISCAL YEAR 2007-2008, PURSUANT TO THE RECENTLY APPROVED MEMORANDUM OF UNDERSTANDING FOR THE INTERNATIONAL ASSOCIATION OF FIREFIGHTERS, LOCAL 55.**

**WHEREAS**, the Memorandum of Understanding between the City of Oakland and the Deputy City Attorney V and Special Counsel Association has been approved by the parties pursuant to *Section 3505.1 of the Government Code of the State of California*; and

**WHEREAS**, the Memorandum of Understanding between the City of Oakland and the International Association of Fire, Local 55 has been agreed to by the parties pursuant to Section 3505.1 of the Government Code of the State of California; and

**WHEREAS**, said agreements have been, and are, approved; now, therefore increases to salaries of 4% for both fiscal years 2006-07 and 2007-08 for employees represented by the Deputy City Attorney V and Special Counsel Association and salaries of 4% for fiscal year 2007-08 for employees represented by the International Association of Firefighters, Local 55.

**THE COUNCIL OF THE CITY OF OAKLAND DOES ORDAIN AS FOLLOWS:**

**Section 1.** Effective, date of passage, the classifications and associated salaries listed in the current Memoranda of Understanding between the City and the Deputy City Attorney V and Special Counsel Association, are increased by 4% effective July 1, 2006.

**Section 2.** Effective, date of passage, the classifications and associated salaries listed in the current Memoranda of Understanding between the City and the Deputy City Attorney V and Special Counsel Association, are increased by 4% effective June 30, 2007.

**Section 3.** Effective, date of passage, the classifications and associated salaries listed in the current Memorandum of Understanding between the City and the International Association of Firefighters, Local 55, are increased by 4% effective June 30, 2007.
