RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF GEORGIA RICHARDSON TO THE CHILDREN'S FAIRYLAND BOARD

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, the Bylaws of Oakland Children's Fairyland, Inc., dated October 26, 2006, note that its Board's function is to assist Children's Fairyland by providing funds and services and to develop, cultivate and advocate greater public interest in Children's Fairyland; and

WHEREAS, the Children's Fairyland Board consists of eleven (11) members, eight appointed by the Board and four by the City of Oakland, three by the Mayor and one a City Administrator's designee, all four being confirmed by the City Council; and

WHEREAS, the Honorable Mayor Jean Quan has appointed Georgia Richardson to serve a three year term, subject to confirmation by the City Council; now therefore be it

RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of Georgia Richardson for a three year term beginning April 1, 2010 and ending March 31, 2013 to the

Children's Fairyland Board, filling the seat she previously held.
