RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A PROFESSIONAL SERVICES CONTRACT WITH DR ASSOCIATES INTERNATIONAL FOR PRE-EMPLOYMENT BACKGROUND AND CONFIDENTIAL INVESTIGATIONS OF FIREFIGHTER/EMT AND FIREFIGHTER/PARAMEDIC APPLICANTS IN AN AMOUNT NOT TO EXCEED FIFTY TWO THOUSAND ONE HUNDRED TWENTY FIVE DOLLARS (\$52,125)

WHEREAS, the City of Oakland Fire Department desires to provide pre-employment background and confidential investigations on applicants for firefighter/EMT and firefighter/paramedic positions; and

WHEREAS, the Fire Department desires to perform investigations on all applicants prior to employment selection; and

WHEREAS, the process is performed to ensure that the City obtains the most desirable qualified applicants for employment with the City; and

WHEREAS, DR Associates International is experienced in such investigations; and

WHEREAS, the City Council finds that services under this contract will be temporary; and

WHEREAS, the City Council find and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive services; and

WHEREAS, the City Council finds and determines that the performance of this contract is in the public interest because of economy; now, therefore, be it

RESOLVED, that the City Council authorize the City Manager or his designee to execute for and on behalf of the City of Oakland, an agreement with DR Associates International to provide 139 pre-employment background and confidential investigations on firefighter/EMT and firefighter/paramedic applicants for the period January 13, 2003 and ending January 12, 2005, in an amount not to exceed fifty two thousand one hundred twenty five dollars (\$52,125); and, be it

FURTHER RESOLVED: That the Office of the City Attorney shall review and approve said agreement as to form and legality prior to execution and copies will be filed in the Office of the City Clerk.


