RESOLUTION AUTHORIZING THE CITY MANAGER, ON BEHALF OF THE CITY OF OAKLAND, TO ENTER INTO A PROFESSIONAL OR SPECIALIZED SERVICE AGREEMENT WITH THE OAKLAND UNIFIED SCHOOL DISTRICT IN AN AMOUNT NOT TO EXCEED \$75,000 FOR FISCAL YEAR 2002-03 TO SUPPORT THE POSITIVE SCHOOL ATTENDANCE INITIATIVE ATTEND AND ACHIEVE - EVERY DAY COUNTS CAMPAIGN

WHEREAS, the City of Oakland desires to support Oakland youth to stay in school; and

WHEREAS, the Oakland Unified School District and the City of Oakland worked together to address the issue of truancy in fiscal years 1999-2001; and

WHEREAS, the City Council appropriated \$150,000 in the Fiscal Year 2001-03 adopted budget to support the operation of a truancy center in east Oakland; and

WHEREAS, the Oakland Unified School District operated the Eastside Truancy Center in East Oakland during the 2001-02 school year and closed it in June, 2002; and

WHEREAS, for fiscal year 2002-03, the Oakland Unified School District eliminated all truancy centers and initiated the Positive School Attendance Initiative Attend and Achieve-Every Day Counts Campaign to provide 11 student attendance coordinators as case managers for habitually truant students to improve student attendance; and

WHEREAS, the Council of the City of Oakland wishes to address truancy by supporting the Positive School Attendance Initiative Attend and Achieve-Every Day Counts Campaign and to make the appropriation of \$75,000 for FY 2002-2003 available to support one coordinator and three student/family workshops; now therefore, be it

RESOLVED: That the City Manager or his designee as agent of the City of Oakland is hereby authorized to enter into a professional or specialized service agreement with the Oakland Unified School District in an amount not to exceed \$75,000 for fiscal years 2002-03 to support the Positive School Attendance Initiative Attend and Achieve - Every Day Counts Campaign that addresses truancy issues in the district; and, be it

FURTHER RESOLVED: That the City Manager is hereby authorized to approve any subsequent amendments to or extensions of said Professional or Specialized Services Agreement with the exception of an increase in compensation provided that such amendments or extensions shall be approved by the City Attorney's Office and shall be filed with the City Clerk's Office.
