**RESOLUTION WELCOMING TO OAKLAND STOPWASTE.ORG, A JOINT POWERS AGENCY THAT PROVIDES STRATEGIC PLANNING, RESEARCH AND TECHNICAL ASSISTANCE TO THE PUBLIC, LOCAL GOVERNMENTS AND BUSINESSES AND INNOVATIVE PROGRAMS AND FACILITIES TO MAXIMIZE WASTE PREVENTION, RECYCLING AND ECONOMIC DEVELOPMENT OPPORTUNITIES**

**WHEREAS**, StopWaste.Org is the Alameda County Waste Management Authority and the Alameda County Source Reduction and Recycling Board operating as one public joint-powers agency composed of the County of Alameda, each of the fourteen cities within the county, and two sanitary districts; and

**WHEREAS**, StopWaste.Org helps create an aware and educated public that has adopted the values and behaviors associated with conservation and sustainability with respect to the consumption and disposal of materials and natural resources; now, therefore, be it

**RESOLVED**, that the City of Oakland welcomes the Alameda County Waste Management Authority Board, the Alameda County Source Reduction and Recycling Board, and StopWaste.Org staff to their new location at 1537 Webster Street in Oakland; and be it

**FURTHER RESOLVED**, that the City of Oakland congratulates StopWaste.Org for purchasing and remodeling an existing building, in a public transit friendly location, and for aiming for a Platinum Rating from the Leadership in Energy and Environmental Design (LEED) Green Building Rating System™ the nationally accepted benchmark for the design, construction, and operation of high performance green buildings, all of which are consistent with the mission of StopWaste.Org and the values of its new host community.
