Distribution From the Virginia A. Baldwin Trust To The Oakland Public

Library In The Amount of \$75,000

#### **SUMMARY**

Staff requests City Council adoption of a resolution authorizing the City Administrator to accept and appropriate a distribution by the trustee of the Virginia A. Baldwin Revocable Trust to the Oakland Public Library in the amount of \$75,000.

#### FISCAL IMPACT

There is no fiscal impact on the City's General Fund. Funds received will be deposited and appropriated to the Oakland Public Library Trust Fund (7540) in a project number to be assigned. This donation was not anticipated and therefore not included in the City's budget.

## **BACKGROUND**

Virginia A. Baldwin established a trust to facilitate the distribution of her property after her death. She died in October 2010. The Virginia A. Baldwin Trust provides that the Oakland Public Library, City of Oakland is to receive the proceeds of trust property which are to be used for library purposes. The Oakland Public Library received the first partial distribution in the amount of \$75,000, representing the bulk of the funds, on July 6, 2011. The trustee has advised the Oakland Public Library that there will be an additional and final distribution of approximately \$10,000.

# PROJECT DESCRIPTION

The donation will be used as required by the Virginia A. Baldwin Trust for the Oakland Public Library. The Library will assess several areas of need (collections, capital, equipment, programs, etc.) and provide funds based on the needs assessment.

# **KEY ISSUES AND IMPACTS**

The Oakland Public Library depends on donations from individuals and organizations to fund projects and programs that cannot be funded through the City of Oakland's budget. Donations such as the distribution from the Virginia A. Baldwin Trust improve the quality of library services in Oakland.

# SUSTAINABLE OPPORTUNITIES

*Economic:* The donation provides funding for library services available to all Oakland residents to enhance their educational and economic opportunities.

Environmental: No specific environmental opportunities have been identified.

**Social Equity:** The services of the Oakland Public Library are available at no charge to all residents of all ages to acquire knowledge and develop the skills they need to assure equity in educational, employment, housing and community opportunities.

# DISABILITY AND SENIOR CITIZEN ACCESS

All Oakland Public Library facilities are ADA accessible.

## RECOMMENDATION

Staff recommends that the City Council approve a resolution authorizing the City Administrator to accept and appropriate a distribution by the trustee of the Virginia A. Baldwin Revocable Trust to the Oakland Public Library in the amount of \$75,000 and future distributions from the same source.
