

INTRODUCED BY VICE MAYOR LARRY E. REID

RESOLUTION AUTHORIZING VICE MAYOR LARRY REID TO TRAVEL TO SEATTLE WASHINGTON TO ATTEND THE 2013 NATIONAL LEAGUE OF CITIES ANNUAL CONFERENCE AND EXPO FROM NOVEMBER 13-16, 2013

WHEREAS, Vice Mayor Larry Reid, City of Oakland's delegate to the National League of Cities, wishes to represent the City of Oakland at the 2013 National League of Cities Annual Conference and Expo from November 13-16, 2013; and

WHEREAS, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City and/or Redevelopment Agency funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation is \$500 (\$400 air; \$100 ground), of lodging is \$1,200, of per diem is \$224, of conference registration fees is \$560, and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project funds; and

WHEREAS, Vice Mayor Larry Reid seeks Council approval of the aforementioned estimated costs to travel to Seattle Washington to attend the 2013 National League of Cities Annual Conference and Expo, November 13-16, 2013; now, therefore, be it

RESOLVED: That all expenses incurred for said travel are hereby authorized.


