

INTRODUCED BY COUNCILMEMBER DESLEY BROOKS

RESOLUTION AUTHORIZING COUNCILMEMBER DESLEY BROOKS TO TRAVEL TO MILWAUKEE, WISCONSIN TO ATTEND THE 2013 NATIONAL LEAGUE OF CITIES NATIONAL BLACK CAUCUS OF LOCAL ELECTED OFFICIALS (NBC-LEO) ANNUAL SUMMER CONFERENCE FROM JULY 31, 2013 TO AUGUST 3, 2013

WHEREAS, Council Member Desley Brooks, City of Oakland's delegate to the National League of Cities, wishes to represent the City of Oakland at the 2013 National League of Cities National Black Caucus of Local Elected Officials (NBC-LEO) Annual Summer Conference in Milwaukee, Wisconsin from July 31, 2013 to August 3, 2013; and

WHEREAS, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City and/or Redevelopment Agency funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation (including airfare and taxis) is \$880.00, of lodging is \$975.00 for five nights, of per diem is \$336.00 for six days, of conference registration fees is \$205.00, of membership renewal fees is \$55.00; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project funds; and

WHEREAS, Council Member Desley Brooks seeks Council approval of the fore mentioned estimated costs to travel to Milwaukee, Wisconsin to attend the 2013 National League of Cities National Black Caucus of Local Elected Officials (NBC-LEO) Annual Summer Conference, July 31, 2013 to August 3, 2013; now, therefore, be it


RESOLVED: that all expenses incurred for said travel are hereby authorized.
