SUBJECT: Report on the Status of State and Federal Legislative Advocacy

Following up on our presentation to the City Council on May 21, 2013, Townsend Public Affairs, Inc. (TPA) will start providing monthly updates on pending State and Federal legislation for the City Council's review and discussion.

Oakland, either by action of the Mayor or the City Council or both, has already taken positions on many pieces of legislation this session. Most of the bills address the Council's top priority categories. Our presentation on June 4 will include additional bills worth your attention. The legislation will be categorized based on the Council's adopted eight priority categories:

- Public Safety
- Economic Development
- Planning, Housing and Land Use
- Youth
- Infrastructure
- Environment and Sustainability
- Constitutional Changes
- Miscellaneous/Other

Friday, May 31, 2013 is the deadline for bills to be passed out of the house of origin. This significant deadline determines which pieces of legislation move forward to the other house in this legislative session. With that said, at the time of submitting this report some bills we are tracking for the City may not be moving forward this session. The following tables list bills on which Oakland has already taken or is in the process of taking a position as of May 23, 2013.
