RESOLUTION HONORING COURTNEY RUBY FOR 13 YEARS OF EXEMPLARY SERVICE AS THE ELECTED CITY AUDITOR OF OAKLAND

WHEREAS, in November 2006, Courtney Ruby was elected to her first of four terms as Oakland's City Auditor and was elected again in 2010, 2018, and 2022 and served a total of 13 years as Oakland's City Auditor; and

WHEREAS, in her first two terms as the elected City Auditor, Courtney Ruby transformed a troubled and ineffective auditing office into a model performance auditing organization, one focusing on accountability, transparency, and results; and

WHEREAS, Courtney Ruby was an outstanding leader and had a clear vision to focus audit work on those issues of the greatest concern to Oakland residents, City leaders, and employees, including homelessness, police reform, fire prevention, information technology security, public works, and the City's financial condition; and

WHEREAS, Courtney Ruby inspired her staff with her vision, values, and inclusive leadership style, resulting in a highly motivated and productive staff, as well as an ethical and respectful work environment; and

WHEREAS, as an independent auditor, Courtney Ruby established effective working relationships with elected officials, City Administrators, Department heads, other City officials, and the residents of Oakland; and

WHEREAS, Courtney Ruby developed a strong relationship with the residents of Oakland by communicating directly with them through newsletters, social media, community meetings, and other means to inform the residents of how their local government was performing; and

WHEREAS, in 2008, Courtney Ruby sponsored the "Whistleblower Protection Act", to protect local government employees in California who have exposed fraud, waste, and abuse; and

WHEREAS, in 2009, Courtney Ruby established a Fraud, Waste, and Abuse Hotline, which received nearly 900 complaints over her last five years as City Auditor; and

WHEREAS, in 2010, Courtney Ruby co-hosted the first mandatory citywide ethics training for managers; and

WHEREAS, in 2011, Courtney Ruby published the City of Oakland's first Ethical Climate Survey, which established a baseline to measure Oakland's progress towards creating a more ethical work environment; and

WHEREAS, in 2013, the Association of Local Government Auditors awarded her Office the Knighton Award, for the best audit report in the country, for the audit entitled, "Non-Interference in Administrative Affairs", and in 2021 awarded her Office with distinguished honors for the audit of the "Oakland Police Commission and the Community Police Review Agency"; and

WHEREAS, in 2014, the American Center for Government Auditing named Courtney Ruby one of the 15 most influential professionals in government auditing for demonstrating the courage, integrity, and leadership necessary to confront and overcome political pressures and other constraints of working as a public sector auditor; and

WHEREAS, throughout her career with the City of Oakland, Courtney Ruby was a hardworking, and dedicated elected official, who consistently and thoughtfully performed her duties with integrity, compassion, and deep respect for Oakland's residents, City leaders, and employees; and

WHEREAS, Courtney Ruby has left the City of Oakland to become the Independent Performance Auditor for the San Diego Association of Governments; and

WHEREAS, Courtney Ruby has made significant contributions to improving accountability and promoting transparency in the City of Oakland and will be deeply missed by her staff, friends, colleagues, and the people of Oakland; now, therefore, be it

RESOLVED: That the Oakland City Council recognizes and honors Courtney Ruby for her extraordinary service and vast contributions to the City of Oakland.


