NOTICE AND DIGEST

Adopt An Ordinance Amending Oakland Municipal Code Chapter 5.91 To: (1) Prohibit The Sale Of Flavored Tobacco Products; (2) Require The Posting Of The Full Retail Price Of Tobacco Products; (3) Prohibit The Redemption Of Tobacco Discounts And Coupons; And (4) Make Administrative Changes For The Licensure Of Tobacco Retailers

This ordinance makes several substantive changes to Oakland's existing Tobacco Retailer License rules under Chapter 5.91 of the Oakland Municipal Code. The changes are intended to discourage tobacco consumption amongst youth and the general population. Substantive changes include prohibiting retailers from selling of flavored tobacco products while exempting "Tobacco Stores" and requiring retailers to post the full retail price of tobacco products as well as prohibiting discounts and coupons for tobacco products. The ordinance also clarifies and defines terms in the administrative provisions of Chapter 5.91 to facilitate the implementation and enforcement of the local Tobacco Retailer License rules.

This Ordinance was introduced at the City Council meeting, Tuesday evening **July 18, 2017**, and passed to print **7 Ayes, 1 Absent-Brooks**. Final adoption has been scheduled for the City Council meeting Tuesday evening **September 19, 2017, 5:30 p.m.**, at One Frank H. Ogawa Plaza, Council Chamber, 3rd floor, Oakland, California.
