RESOLUTION WAIVING THE COMPETITIVE REQUEST FOR PROPOSAL PROCESS FOR A PAY-GO FUNDED CONTRACT IN THE AMOUNT OF \$40,000.00 WITH VOLUNTEERS FOR OUTDOOR CALIFORNIA (V-O-CAL), A NON-PROFIT VOLUNTEER TRAIL BUILDING AND MAINTENANCE ORGANIZATION, FOR CONSTRUCTION OF A NEW TRAIL AT GLENN DANIELS TRAILS/KING ESTATES OPEN SPACE

WHEREAS, on July 17, 2007, the City Council revised the pay-go procedures to preapprove use of pay-go for City of Oakland infrastructure, furniture or equipment expenditures, or to grants to other government agencies for infrastructure, furniture or equipment expenditures; and

WHEREAS, pay-go expenditures are subject to the City's purchasing requirements and programs and Oakland Municipal Code Section 2.04.051.A requires staff to conduct a request for proposal process for capitol improvement design and project management contracts over twenty five thousand dollars (\$25,000.00) unless the City Council waives the requirement; and

WHEREAS, Volunteers for Outdoor California (V-O-CAL) is a nonprofit organization dedicated to providing a volunteer workforce for large-scale trail maintenance and construction projects, habitat restoration and related land stewardship activities on public lands, in partnership with public agencies and other non-profit organizations; and

WHEREAS, V-O-CAL has constructed public trails throughout California since 2006, at a significant cost savings to public entities by organizing and managing large groups of volunteers to do the work; and

WHEREAS, V-O-CAL has proposed to design and construct a new trail at Glenn Daniels Trails/King Estates Open Space for the cost of forty thousand dollars (\$40,000.00) at a significant savings to the City of Oakland, which is a pre-approved pay go eligible expenditure; and

WHEREAS, it is in the best interests of the City to waive the request for proposal process and authorize the contract for design and construction of a new trail at Glenn Daniels Trails/King Estates Open Space with V-O-CAL; and

WHEREAS, Vice Mayor Larry Reid wishes to use forty thousand dollars (\$40,000.00) of his pay-go funds to pay for design and project management services rendered by V-O-CAL for construction of a new trail at Glenn Daniels Trails/King Estates Open Space; now, therefore, be it

RESOLVED: That, pursuant to Oakland Municipal Code Section 2.04.051.B and based on the information set forth above, the City Council finds that it is in the best interests of the City to waive the request for proposal process for design and construction of a new trail at Glenn Daniels Trails/King Estates Open Space, so waives the requirement and authorizes the City Administrator to enter into a contract with Volunteers for Outdoor California (V-O-CAL) for said work in an amount not-to-exceed forty thousand dollars (\$40,000.00) for construction of a new trail at Glenn Daniels Trails/King Estates Open Space.
