**RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF  
SHARON CRAVANAS AS A MEMBER OF THE LIBRARY ADVISORY COMMISSION**

**WHEREAS**, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

**WHEREAS**, Ordinance No. 8064 C.M.S, adopted November 13, 1969 and amended by Ordinance No. 11730 C.M.S., adopted July 26, 1994, establishes the Library Advisory Commission to advise and make recommendations on the operation and future development of the library system and to act as a liaison between the Library Department and the Mayor and City Council; and

**WHEREAS**, the Library Advisory Commission consists of fifteen (15) members serving not more than two consecutive three year terms; and

**WHEREAS**, the Honorable Mayor Jean Quan as appointed Sharon Cravanas to serve a three year term subject to confirmation by the City Council; now therefore be it

**RESOLVED**, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of Sharon Cravanas to the Library Advisory Commission for a three year term beginning November 17, 2012 and ending November 16, 2015, filling the seat previously held by Charles Sanchez.
